

ERRATUM ONEKIN! DIGITALA

On 12/11/2021 an erratum has been corrected on page 9 of the rules, since it was indicated that the maximum number of companies that must form the group was 4, when in fact it is the minimum number.

On 18/11/2021, the reference to the requirement of 3 contracts that appeared in point 4.2. and 5.c. has been corrected. In the case of implementation, it will only be necessary to submit 3 bids from different suppliers in the application when the amount to be contracted exceeds the amount corresponding to the Minor Contract referred to in Law 9/2017, of November 8, on Public Sector Contracts.

However, it will be necessary to submit 3 bids from different suppliers or justify the non-submission in the case of consulting projects mentioned in 4.1.

On 19/11/2021, the application deadline was extended from December 2nd, 2021 to the day after, December 3rd, 2021.

"Digital Transformation Team"

Grouping formed for the purposes of the "ONekin Digitala" Program to address a need or to take advantage of a specific opportunity in the field of digitalization.

The constitution of the Digital Transformation Team must pursue a clearly identifiable objective, for example:

- evaluate the scope of a given technological solution in the face of different scenarios or situations, or,
- address the same need or opportunity with different technological solutions.

These groupings of individuals or legal entities may be established with or without legal personality and must be composed of at least 3 members, distinct individuals or legal entities that do not necessarily have organizational, functional or economic relationships with each other.

In these groupings, each and every one of the individuals or legal entities that participate in them will be considered as beneficiaries, and must comply with the conditions established in this Program and each one of them must make their application. These groups must expressly state in the application the commitments assumed, as well as the amount of subsidy to be applied to each one of them, who will also be considered as beneficiaries.

In any case, they will have to appoint a representative or sole proxy of the grouping with sufficient powers to fulfill the obligations that, as beneficiary, correspond to the grouping. This person will be the sole representative or attorney-in-fact of the group, who will sign and submit the application on behalf of the Digital Transformation Team.





Deadlines:

- Applications for assistance must be made from 11/19/2021 to 12/3/2022.
 - o The budget of the action to be undertaken must be included in the application.
 - o In case of execution, the proforma invoice and proof of payment may also be included.
- The execution of the project must be carried out between 01/01/2011 and 05/31/2022.
 - o In the event that the project has not been executed or invoiced prior to the application, the invoice and proof of payment must be submitted with a deadline of 31/05/2022. Unless there is a justified error or modification, the amount of the invoice will correspond to the figure established in the presentation of the application together with the budget.
- The deadline for the submission of the reports, invoices and proof of payment (or that which is obligatory for the closing of the project) will be 30/06/2022.
